Case Context

- TfS offers a standardised assessment & audit process for clients & suppliers in the chemical industry.
- Wacker, a member of TfS, is a leading manufacturer of solar panels, operating a complex supply chain.
- Wacker, together with other chemical sector companies, shares a supplier database base covered by TfS assessments & audits.
- Wacker uses the same assessment tools to provide sustainability metrics to its customers, thereby providing consistent and standardised results for all members of the initiative.

Approach under TfS Initiative

- Chemical company procurement departments working with assessment partners to establish an actionable assessment & audit program.
- Pre-engagement with suppliers to encourage compliance & build trust in the TfS assessment & audit initiative.
- Training & engagement built into the process, to assist suppliers through the assessment & audit scheme.
- Focus on working together to improve supplier performance & not as a pass/fail exercise.



Challenges Being Addressed by the TfS Initiative

- Suppliers required to fill in too many questionnaires from different customers, creating inconsistency in compliance & heavy workload. Particularly an issue for small sized companies.
- Initial hesitance by suppliers to undergo assessments or audits, as not required under current laws.
- Suppliers struggle to understand & comply with the requirements of an assessment or audit, including preparation of documentation & conducting on-site visits.

Good Practice Elements of TfS Initiative

- The audit & assessment facilitates supplier & customer mapping of sustainable sourcing in under a standardised framework.
- A shared database & assessment results is more efficient use of resources for both suppliers & clients, reducing time & costs for both.
- TfS audit process has been developed in a collaborative approach and its framework and principles can be transferred to other sectors.



The Benefits of a TfS Audit

- Supports company's sustainability commitments.
- By sharing results with multiple clients, reduces efforts & costs for suppliers.
- Allows suppliers to identify issues requiring improvement, using a Corrective Action Plan.
- Efficiency gains through improved use of time & human resources.
- Equivalent to auditing standard: SQAS.
- TFS audits can be combined with other audit subjects: product quality, quality management systems, regulatory compliance etc.

Characteristics of a TfS Audit

- Standardised audit process covers five aspects of sustainability procurement.
- All members can access database for supplier audit results, thereby decreasing time & effort for suppliers & procurement departments.
- Not a certification exercise with pass/fail results.
- Supplier & client work together to continuously improve performance.
- Supplier/Customer confidentiality assured.
- Validity 1-3 years, depending on result.

Process for a TfS Audit (1)

1

Supplier Selection by Client

- Define supplier audit strategy
- Communicate audit requirements to suppliers

2

Supplier Invitation from Client

- Nominate a supplier to participate in a TfS audit
- Confirm the supplier nomination
- Invite the supplier to participate in an TfS audit

Opening meeting

Site tour

Interviews

Time: Approximately 3 months (depending on supplier size & location) of supplier

Document review

Closing meeting

TfS Audit Preparation

- Complete the Supplier Academy
- Selected audit company, conclude contract, set date
- Prepare for audit, provide preaudit information & sign DSA

Audit Preparation includes:

- General Information: General information to be completed about your site.
- Audit Preparation Checklist: Lists all of the steps you need to take before an audit.
- Document List: Documents that may be requested by the auditor

TfS Audit

- Opening Meeting
- Site Tour
- Interviews
- Document Review
- Pre-Closing Meeting
- Closing Meeting

Audit conducted by certified, independent audit firms

Closing Meeting & Findings

- Agree on findings & propose corrective actions in closing meeting
- Report Audit Status to TfS Office

Results

- Minor: a concern of low priority
- Major: a concern of high priority
- Critical: a concern of immediate high priority

6

Sharing & Corrective Action Plan (CAP)

- Prepared report shared with supplier
- Review & establish CAP
- Finalise audit report & CAP
- Conduct Quality review of audit
- Upload audit report to TfS database – can be accessed by other clients
